

ORDINANCE NUMBER 2006-06

AN ORDINANCE TO AMEND ORDINANCE NUMBER 2006-02, CREATING RULES AND REGULATIONS FOR SMOKING IN PUBLIC PLACES AND PLACES OF EMPLOYMENT

WHEREAS, Ordinance Number 2006-02 was unanimously passed by the Board of Aldermen on the 21st day of March, A.D. , 2006 for the purposes of protecting the public health and welfare of its citizens by prohibiting smoking in public places and places of employment; and

WHEREAS, It was the intent of the Board of Aldermen to have Ordinance Number 2006-2 published as quickly as possible, allowing for effectuation of said Ordinance to be within the month of May, 2006; and

WHEREAS, The City Clerk did not cause Ordinance Number 2006-2 to be published in the Starkville Daily News until May 19, 2006; and

WHEREAS, As due to the aforementioned circumstances surrounding the publication of Ordinance Number 2006-2, said ordinance would not be potentially effectuated until the 23rd day of July, A.D., 2006; and

WHEREAS, An effective date for Ordinance 2006-2 of the 23rd day of July, A.D., 2006 is contrary to the Board of Aldermen's intent for said ordinance; and

WHEREAS, Pursuant to the provisions of Mississippi Code, 1972 Annotated, §21-13-11 the Board of Aldermen finds due to the confusion regarding the effective date of the ordinance among business owners and patrons the board finds good cause for Ordinance 2006-2 to be in full force and effective immediately this the 24TH day of May, A.D., 2006;

NOW THEREFORE, BE IT ORDAINED, by the Mayor and Board of Aldermen of the City of Starkville:

That Ordinance Number 2006-2 be amended, so that it shall be in full force and effect immediately from and after passage of Ordinance Number 2006*6i* and

That this Ordinance Number 2006-6 shall be in full force and effect immediately from and after its passage in accordance with provisions of Mississippi Code, 1972 Annotated, §21-13-11, which allows for any ordinance for the immediate and temporary preservation of the public peace, health or safety or for other good cause, to be made effective from and after its passage by a unanimous vote of all members of the governing body.

The Clerk is directed to cause this Ordinance to be published one time in the Starkville Daily News on or before, the 31st day of May, A.D., 2006, and to obtain proof of publication thereof.
