Be it remembered that the Mayor and members of the Board of Aldermen met in a Work Session on Friday, November 17, 2023 at 11:00 a.m. in the second-floor conference room of City Hall located at 110 West Main Street, Starkville, MS. Present were Mayor D. Lynn Spruill, Alderwoman Sandra Sistrunk, Alderman Mike Brooks, Alderman Hamp Beatty and Alderman Henry Vaughn. City Attorney Berk Huskison and City Clerk / CFO Lesa Hardin were also present.

Mayor Spruill opened the work session. The work session was properly noticed pursuant to Miss. Code Ann. §25-41-13 and a copy of that notice is included in the minutes. The work session was live streamed on Facebook. The public and media were welcomed and attended. The session is also available for viewing on the City website.

Mayor Spruill introduced Fire Chief Charles Yarbough who along with Freddie Parker, Director of Operations for Pafford EMS, gave an annual overview of services. They noted 2,550 calls had been received in the past twelve months with 66% transported. They also reported the average response time to be six minutes and twelve seconds.

Brandon Doherty, General Manager for Sports Facilities Companies, provided information on the upcoming 2024 sports year and planned events.

The Mayor and members of the Board discussed items on the upcoming November 21, 2023 agenda. Department Directors were available to answer questions related to the items. All agenda items were discussed.
